
#### **EVENT CO-CHAIR**

on congressional issues affecting Cablevision and spearheaded the company's federal advocacy, including on retransmission consent, privacy, cybersecurity, and intellectual property. Before joining Cablevision, Diana served as counsel on the U.S. House of Representatives Committee on the Judiciary, advising the Chairman on a variety of copyright and communications issues, including net neutrality, digital music royalties, online gaming, the constitutionality of the Copyright Royalty Board, and reauthorization of the statutory satellite and cable carriage licenses. After failing four classes his freshman year of high school, Tim's path forward was murky at best.

But thankfully, he had a mom who stuck with him, and met a mentor that showed him the wisdom of conservative principles. Through their belief and his own determination, Tim got his grades



back on track, graduated from Charleston Southern University, and eventually built his own successful small business.

Through the lessons taught by his mentor, Tim developed his mission statement: to positively affect the lives of a billion people. That led him to public service, where he was elected to Charleston County Council, the South Carolina House of Representatives, the United States House of Representatives, and the United States Senate. Since joining the Senate in 2013, Senator Scott has been a national leader on efforts to bring opportunity to every American family. His signature legislation creating Opportunity Zones was passed as part of the 2017 tax reform package, and has the potential to bring billions of dollars of private investment into distressed communities across the country.

As he continues to lead on the implementation of the Opportunity Zones initiative, Senator Scott also plays a critical role in issues regarding workforce development, education and diversity.



Subcommittee on Labor, Health and Human Services, and Education. The people of Southwest Missouri overwhelmingly elected Senator Blunt seven times to the U.S. House of Representatives. Senator Blunt was elected the Majority Whip earlier in his career than any Member of Congress in eight decades, and he was elected to the Senate leadership during his first year in the Senate. Before serving in Congress, he was a history teacher, a county official, and in 1984 became the first Republican elected as Missouri's Secretary of State in more than 50 years. Senator Blunt also served four years as the president of Southwest Baptist University, his alma mater, in Bolivar, Missouri. Senator Blunt earned an M.A. in history from Missouri State University.

Senator Blunt is a member of the Smithsonian Council for American Art and is a Trustee of the State Historical Society of Missouri. Senator Blunt is also a member of the Kennedy Center Board of Trustees.

The Senator is married to Abigail Blunt and has four children: Matt Blunt, Amy Blunt, Andy Blunt, and Charlie (age 16).


